Bridal Coordination Fee

ALL Bridal Reservations made with our LUXE. Bridal Team will acquire a Bridal Coordination Fee of \$50.00 in addition to the applicable amount due for a Bridal deposit. The purpose of a Bridal Coordinator is to ensure that our LUXE. Bride is receiving an unmatched experience tailored specifically with her needs in mind. Beginning with our Brides initial inquiry all the way through to the follow up correspondence after Bridal services have conducted, our Bridal Coordinator is available to our Brides during and outside of business hours to ensure full communication the entire experience through. Coordinating and conducting our Brides trial run appointments, Bridal hair prep appointment, day of services and inventory prep for each of these individual services are just a few of the responsibilities that go under the direction of our Bridal Coordinator.

Deposits & Cancellations

All reservations require a credit card to be stored on file to couple our client's demographic information. A deposit in the amount of half the total for services being requested for the Bride only, will be due in lieu of a signed LUXE. Bridal Contract. The remaining balance due for the Brides service(s) only, will be due at checkout following your Bridal "trial run" appointment. **ALL PAYMENTS made for Bridal services with LUXE Salon and Spa are NON-REFUNDABLE, to include both the Bridal deposit and coordination fee.** All services being requested per reservation must be confirmed no more than 14 days prior to the reservation date per contract. In the event a reservation and/or requested services are cancelled within our allotted 14-day period, it is the responsibility of the client to fulfill half the applicable balance due for the assumed bridal service(s) per contract. All cancellations and/or modifications made to a Bridal reservation must be acknowledged and confirmed by submitting a written request via email to, jessykamae@gmail.com.

How To Prepare ...

When preparing for your Bridal trial run appointments you'll want to take into consideration what you'll need to achieve your ultimate Bridal look on the day of as well as what may set you as well as your Bridal Artists up for success when executing your desired look. Attached to your Bridal Welcome Packet is a Bridal Checklist on how to become your best self when preparing for your big day! This list should also be considered when preparing for your trial run appointment!

LUXE. Recommendations ...

- Consulting with a LUXE. Habit Handtied Hair Extension Specialist
- Consult and conduct your first appointment with a LUXE. Hair Artist prior to your trial run
- Brow shaping 1 week Prior to trial run appointment
- Exfoliate and moisturize the night prior to your trial run
- Come to your trial run appointment with freshly cleansed face and washed/blown out hair

What To Bring ...

- Inspiration photos that reflect desired hairstyle and makeup application goals
- Hair extensions and/or hair enhancement pieces necessary to achieve desired hairstyle
- Any hair adornments, clips, pins and/or vails for consideration of your desired hairstyle
- LUXE. offers classic, volume and individual false strip lash enhancements, if you have a preference on a strip lash type that we do not carry in salon, please consider purchasing your perfect pair prior to your trial run appointment

Preparing For The Day Of ...

Following your trial run a month prior to your reservation date, your Bridal Coordinator will work with you to create a Bridal timeline for the day of services in which you've requested. This timeline along with any additional Bridal services being requested will be confirmed no more than 14 days prior to your reservation date! A confirmation of this information will be emailed to the address noted per your LUXE. Bridal Contract!

Creating a Timeline ...

When creating a timeline with your Bridal Coordinator, we will need to consider the following:

- Travel time to the wedding venue
- Photographer timeline, ie; "getting into the dress" photos place/start time and "first look" and/or family photo start time
- Ceremony start time

Bridal Party Preparation ...

To alleviate any discrepancies with the noted timeline on the day of your Bridal Parties services, please confirm that each person receiving services have either a hairstyle and/or makeup application inspiration photo ready to present to their Artist at the time of service!

- It is recommended that all persons being serviced wear either a loose-fitting blouse and/or a button down top. This will ensure the retention of your services while transitioning into formal wear!
- ALL guests being serviced for hair: Please clarify AND blow-dry hair the day PRIOR to the wedding. Leave-in styling aides are appropriate following a shampoo; however, it is our recommendation that any styling aides being used the day prior be applied with discretion. This recommended process will ensure a "prepped & ready" look for our Artists once the guest is in their chair for styling!
- ALL guests being serviced for makeup: Please exfoliate and moisturize the face, lips and decollate area the night prior to the reservation date for services! It's recommended each person receiving a makeup service come prepared with a lip color of choice to reapply throughout the remainder of the wedding day. LUXE. does offer touch up lip colors for purchase on the day of if desired!

Be Your Best Self!

To ensure you are feeling like your absolute best self on your wedding day, LUXE. Salon and Spa has collaborated with Spokane's local Whole Body Medi Spa to create a checklist of recommended services to consider while prepping for your day of Bridal glow!

10-12 Months

- Schedule a 30-minute consultation to reserve your LUXE. Bridal Experience and day of services
- Evaluate stress, sleep & diet; Healthy eating, weight loss/maintenance, exercise plan and establish a skincare routine
- Schedule monthly Signature LUXE. Facial/HydraFacial appointments; All Brides receive a complimentary Epionce skin care regime sample kit at first Facial appointment!
- Consult with a LUXE. Brow Specialist to begin a tint and design combo regime
- Consult to begin a Whole Body Medi Spa laser hair removal treatment

6-9 Months

- Clear and Brilliant Skin Rejuvenation Treatment with Whole Body Medi Spa
- Consultation for Botox
- Wear sunscreen daily – Face, neck, chest and back
- LUXE. Recommendation: Epionce Daily Shield Lotion Tinted SPF 50
- Consult with your LUXE. Bridal Hair Artist to schedule appointments for; color services, protein treatments and hair maintenance

3-5 Months

- Daily vitamins and nutritious drinks / no energy drinks
- Whole Body Medi Spa Recommendation: Myers Cocktail
- Regular IV vitamin infusions or weekly injections
- First appointment with your LUXE. Bridal Hair Artist for your scheduled color service, protein treatment and hair maintenance (4 months)
- Order hair extensions if being considered (4 months)

1-2 Months

- Bi-weekly massages
- Full set of LUXE Artistry Lash Extensions
- Daily under eye hydration patches & serums –
LUXE Recommendation: Epionce Renewal Eye Cream
- Stop drinking alcohol and limit sugar & simple carbs
to decrease bloating and breakouts
- Second appointment with your LUXE. Bridal Hair Artist for color/hair maintenance and Protein
treatment color match hair extensions and blending method if
hair extensions are desired (2 months)
- Conduct the LUXE. Experience Bridal Trial Run appointments (1 months)
- Schedule a final Clear and Brilliant facial + Botox touch up with Whole Body Medi Spa

1-2 Weeks

- Last laser hair removal treatment with Whole Body Medi Spa
- LUXE. Brazilian and/or body waxing
- LUXE. Brow tint and design combo (1 week)
- LUXE. Lash Artistry - fill (3-4 days)
- Signature LUXE. HydraFacial and/or dermaplaning (2 days)
- Infinity Sun LUXE. Airbrush spray tan (2 days)
- LUXE. Bridal Experience Wedding Day Hair prep shampoo/blowout appointment – add a
signature glossing treatment to promote shine and rich dimensional tones to your hair on
your wedding day
